TERMS AND CONDITION

**1) Quotation Submission Requirements**

- Supplier must submit a duly accomplished and signed Price quotation and supplier's line Technical Specifications
- Supplier's Certification. Annex "A"
- Suppliers must be PhilGEPS registered.
- Business Permit/License Permit
- Certification of Authorized Dealership/Distributor

**2) Evaluation and Awarding of quotation**

- The purchaser will evaluate and compare the offers, which have been determined as responsive pursuant to the completeness of the purchaser requirements;
- Compliance to the technical specifications;
- Awards shall be made to the lowest evaluated and responsive offer.
  - The DENR shall have the right to terminate this Agreement, through a written notice to the Recipient P.O., if it considers that the continued implementation of the Agreement is not practicable.
    1. Force majeure or unforeseen causes beyond the control of the DENR or the Recipient P.O;
    2. In the event of a default on the part of the Recipient P.O., under the following circumstances;
      - 2.1 Fraud, misrepresentation or omission of material facts in the preparation of the COA which would otherwise disqualify the P.O;
      - 2.2 Failure to start the project on the date specified in the work and financial plan without just cause;
      - 2.3 Abandonment of the project area, or of the work stipulated in the WFP, for a period of at least one month from the date of discovery by DENR of such fact;

**3) Delivery Site- Within Plantation Site**

**4) Terms of Payment**

1. In the event of the Recipient P.O.'s with the terms of this agreement, after having been subjected to due process, it shall refund to the DENR any payment already received in respect to activities that have not been performed by the Recipient P.O in accordance to a standard considered acceptable to the DENR.
2. In the event of termination by the DENR due to unforeseen causes beyond its control, the DENR shall complete all payments due to the Recipient P.O. for activities already conducted.
3. The recipient P.O. is hereby prohibited from sub-contracting wholly or part of activities contracted without consent from the Secretary of the DENR or his duly designated representative. If ever sub-contracting will be authorized, the recipient P.O. shall continue to be primarily liable of the project's implementation under this agreement and the DENR shall not be accountable for any and all claims brought by the sub-contractor. Any sub-contracting agreement entered into in violation of the terms and conditions of this LOA shall be null and void.
4. This prohibition, however, does not cover the traditional practice of availing labor services known as "Pakyaw System";
5. The Recipient P.O. is responsible and accountable for the protection and maintenance of the plantation established and ensure that the survival rate at least 85% of the total out planted seedlings and the area contracted;
6. 100% of the contract price will be paid upon inspection and acceptance of the items delivered.

**5) Liquidated Damages**

- 1/10 of one percent for every day delay shall be imposed.

**6) Taxes**

- Applicable government taxes shall apply.
